It has always been difficult to put the work of YWCA Edmonton into a brief statement. The fact is, we have evolved significantly over the last 113 years in response to the changing needs of our city. We now offer very diverse services to a wide range of people.

Most notably, YWCA Edmonton partnered with Compass Sexual Health and Wellness Centre to expand services by integrating their sexual health and wellness programs into the YWCA. These new services align perfectly with our values. We are proud to offer sexual health support to our community.

The thread that runs through all our work at the YWCA is a commitment to building, supporting, and inspiring open-minded leaders to advocate for equity and equality in our community. The statistics and stories you'll read in this year's Annual Report illustrate our commitment and determination to create a brighter future for all.

The submission of this report coincides with the exciting announcement of YWCA Edmonton's new CEO, Katherine O'Neill, who will join us in March of 2020. We are thrilled to welcome Katherine and look forward to her vision and leadership as we continue to serve women and their families, when and where they need us.

Our clients are often dealing with issues of domestic violence, anger management, childhood abuse, sexual abuse, divorce, suicide and a desire for healthier relationships.

Our services operate on the assumption that each individual has the capacity for positive growth. Our counsellors and psychologists assist clients to identify their positive qualities and strengths and help them generate solutions to their problems. The counsellors work with clients to construct a new and better reality.

DIANE'S STORY

As I write this, it has been 73 days since my husband assaulted me. The injuries I sustained—a bruised face, lacerated cheek and fractured cheekbone—have all mostly healed, but the emotional trauma is still very, very raw.

When I married Doug ten years ago, I knew about his past crimes, his violent behaviour; but I fell in love with a man who seemed to truly want a better life.

That changed after our son Dean was born. He started drinking again and soon the abuse started

But I continued to love and support him, until the night he attacked me. He punched me in the head repeatedly, threatened to kill our son and sexually assaulted me.

The most horrific part for me came after the assault. I had to tell Dean, who was eight at the time and worshipped his daddy, that we would never be a family again.

Dean and I are both in therapy now, which is helping us process the turmoil that our lives have been thrown into. But even after everything we've been through, I still can't bring myself to hate Doug. I know he is a product of his life, and I truly hope he finds peace some day.

I have one final thing.

At some point, minutes before his arrest, Doug sent me a text, it said, "Can I have a second chance if I quit?" I have gone over this time and time again in my head, and the answer is simple. The past 10 years and our marriage was the second chance.





Lakeside Haven

VIOLENCE RECOVERY FOR WOMEN AND CHILDREN

Lakeside Haven is a retreat for women and children who have experienced family violence and are currently staying at a local shelter. It is a safe, nurturing space to explore new activities, rebuild relationships, relax and heal as a family.

For many, this is their very first experience leaving the city and often the first vacation they've ever had. Moms get a chance to reconnect with their children away from the pressures of day-to-day life, helping with recovery and moving them forward as a family while creating new, happy memories. They're also able to connect with other women who share their circumstances.

This weekend is designed to be a paradise of positivity, fun and security. Children are given permission to be children again. We aim to show them that life is still good; there are friendships to look forward to, new experiences to be had and chances for more good times in the future.

ADVOCATING FOR EQUITY AND EQUALITY

Advocacy for equity and equality is at the core of our work; it is the thread that runs through all our programs and services. Highlights of 2019 include a collective YWCA submission to the Alberta Government on the provincial budget, as well as the government's implementation of an action plan to combat human trafficking.

COMBATTING HUMAN TRAFFICKING

Since 2011, YWCA Edmonton has been part of coordinated efforts by law enforcement, government and partner NGOs to prevent human trafficking in our province, protect victims, and prosecute traffickers.

In 2019, the Alberta Government announced the implementation of a nine-point **Action Plan to Combat Human Trafficking** to protect at-risk individuals from being trafficked in Alberta, empower survivors of trafficking, and provide new remedies to deal with traffickers. The plan includes creating a provincial Human Trafficking Task Force and introducing legislation to establish a process for restraining orders, torts, and proclaiming a Human Trafficking Awareness Day.

PROVINCIAL BUDGET RECOMMENDATIONS

In October 2019 the Alberta YWCAs of Calgary, Edmonton, Lethbridge and Banff jointly presented a comprehensive budget proposal to the provincial government. As experts on issues related to domestic violence, mental health disability supports, human trafficking, women's equity, housing and homelessness, and childcare, our recommendations addressed the issues faced by the thousands of Albertans we serve across the province every year. The proposal included:

- \$100 million investment into a Mental Health and Addictions Strategy
- Allowing cultural competency to be applied to human trafficking and domestic violence legislation
- Making medical resources available at women's shelters
- Advocating for a revision of the Criminal Code to include domestic abuse as a criminal offence in Canada
- Training shelter workers to recognize the signs of human trafficking





WALK A MILE IN HER SHOES®

Walk a Mile in Her Shoes® celebrated its 10th mile in 2019, raising over \$1,000,000 for YWCA Edmonton since it began. Our community supporters are committed to creating awareness and breaking the cycle of family violence; they stepped up and stepped in to support families in crisis and help them build healthy futures. This signature fundraising event saw people from all walks of life strutting in fabulous footwear and collecting pledges in support of YWCA Edmonton.

As part of our 10th anniversary, we honoured 10-Mile Champions Al Madge, Curtis Hargrove, and David Jones. These three have been an integral part of our Walk a Mile family over the past decade, each going the extra mile in lending their support to Walk a Mile.

ROSE CAMPAIGN

The Rose Campaign is an event that galvanizes community leaders to take action to end violence against women and girls. Commemorating Canada's National Day of Remembrance and Action on Violence against Women, this exclusive, invite-only breakfast is an opportunity to learn more and support of the work of YWCA Edmonton with a meaningful donation.

TREASURER'S REPORT

The top priorities for the YWCA in 2019 were to continue increasing fundraising revenues and reduce our deficit from operations. We ended the year with a profit of \$399,000. This was largely due to expired government grants totaling \$370,000 as well as income from investments of \$146,000. Our goal was to achieve a balanced budget through the continued execution of our fundraising strategy, combined with careful spending across all programs.

The organization's investment in fundraising has proven successful, with all program funding targets being met or exceeded in 2019. There was an overall increase of \$49,000 in fundraising revenue compared to 2018. Fundraising revenue in the Financial Summary includes Donations & Fundraising, Other Government and Foundation Grants, and Casino Revenue.

Overall revenue increased by \$936,000 or 8% over 2018, which, aside from the expired grant, is largely due to increased Fee for Service revenue in Disability Services and Counselling Services, as well as the assumption of two contracts from Compass Sexual Health and Wellness Centre. These increases in revenue were matched by increased expenses required to provide the services.

We purchased \$41,000 of capital assets in 2019, using \$9,780 in designated grants to do so. The majority of the capital asset purchases were office furniture and computer equipment for the new Compass Sexual Health and Wellness services, as well as a used van for Camp Yowochas.

Overall, 2019 was a successful year, and we are very grateful to our donors, supporters, and volunteers. You are the reason the YWCA continues to be a community leader in advocacy, counselling services, disability services, sexual health and wellness, youth programs, and outdoor experiences.
